AMENDMENT NO. 2

Hire of Vehicles and Drivers

CFB Petawawa, Ontario

Amendment No. 2 is raised to answer questions raised by a potential bidder:

Question #1 - Annex "B" BASES OF PAYMENT. On the chart it shows the following;

Item:

2 - RETURN TRIP - Flat rate from CFB Petawawa to Ottawa International Airport and Return to CFB Petawawa

A) 1-3 Pax 200-600 lbs baggage(Mini Van) - Trips 200

B) 4-6 Pax 800-1600 lbs of baggage(Panel Van) - Trips 25

C) 7-25 Pax 1400-5000 lbs of baggage(Mid Size bus) - Trips 5

Do these return trips consist of different shuttle dates (example:

passenger is shuttled to the Ottawa Airport - November 30th and returns from the airport December 5th) ? Or is it the same day service? Does the return trip consist of driving up the hwy twice or once? Are you requesting pricing for a two way booking?

Answer #1 - A 'Return Trip' consists of a single run to and from Ottawa for a pickup / drop-off or combination of the two. If a passenger flies out 30 Nov and returns 5 Dec that would consist of 2 x 'Return Trips'.

Question #2- I also noticed that item 1 & 2, it doesn't specify Z Lines as the start or end point - could the pickup or drop off occur at various locations around CFB Petawawa(North/South side, ranges, exercise grounds)?

Answer #2 - For ease of the contractor, the Z-Lines will be considered as the pickup / drop-off for every trip to and from Petawawa, regardless of destination.

All other terms and conditions remain unchanged.
