AMENDMENT 004

The purpose of this amendment is to publish answers in response to questions received regarding this TBIPS SA RFP.

THE FOLLOWING CLARIFICATION FORMS PART OF THIS TBIPS SA RFP:

Question 1) We have a question in regards to the requirements grids for each of the requested categories. In those instances where the criteria request a certain number of projects and also specify a minimum project duration, will the client allow project equivalency? i.e. If a project is 12 months in length, it could be used as an equivalent of 3 projects of 4 months each where that was the minimum duration specified.

Answer 1) No, the Crown will not allow “project equivalency”. The intent of this scoring approach is to reward diversity of experience on different projects while ensuring that each project is of sufficient duration to provide relevant experience. Using your example, a project of 12 months in duration, will be counted as 1 project, and not the equivalent of 3 projects of 4 months.
