### ANNEX B: RULES OF ENGAGEMENT AGREEMENT

An overriding principle of the industry consultation is that it be conducted with the utmost of fairness and equity between all parties. No one person or organization shall receive nor be perceived to have received any unusual or unfair advantage over the others.

These Rules of Engagement will apply beginning with the signing of this document and concluding with the release of the Request for Proposal (RFP) on the Government Electronic Tendering Service (GETS/MERX<sup>™</sup>).

The Consultation Process will begin with one-on-one meetings. Additional consultation processes may take place as deemed necessary by Canada. Registration will be used to create a participants' list for future consultation as required.

Canada will not disclose proprietary or commercially sensitive information concerning a Participant to other Participants or third parties except and only to the extent required by law.

### **TERMS AND CONDITIONS:**

The following terms and conditions apply to the Consultation Process. In order to encourage open dialogue, participants agree to the following:

- Canada is not obligated to issue any RFP;
- If Canada does release a RFP, the terms and conditions of the RFP shall be subject to Canada's absolute discretion;
- Participants will not reveal or disclose any information to the MEDIA/NEWSPAPER regarding the SMP program during the consultation process. If participants receive a question from the Media, participants are to direct the Media to contact PWGSC's Media Relations Office at (819) 956-2307;
- Participants are to direct inquiries and comments only to authorized representatives of Canada, as directed in notices given by the Contracting Authority from time to time;
- Canada will not reimburse any person or entity for any cost incurred in participating in this industry consultation process;
- One-on-one meetings are only available to potential SMP vehicles original equipment manufacturers (OEM), members of joint venture with a potential SMP vehicle OEM, or a party under license from a potential SMP vehicle OEM;
- Participation is not a mandatory requirement. Not participating in this consultation process will not preclude a bidder from submitting a proposal; and,

- Failure to agree to and sign the Rules of Engagement will result in the exclusion from participation in the one-on-one meetings and any other consultation.
- Lobbyists will not be permitted to participate in the consultation process.
