Bidder must achieve the minimum acceptable points in each (1.2A through 1.2C) of the individual criterion identified below in order to be considered responsive. Failure by the Bidder to achieve the minimum points will render the Bidder's offer non-responsive and will not receive further consideration. Those proposals will then be prorated in accordance with the percentage allocated in the "Contractor Ranking" section for technical/managment.
