Clarification Questions:

Note, questions are numerically sequenced upon arrival at PWGSC. A question and its answer will be provided via MERX as the response becomes available. Potential bidders are therefore advised that questions and answers may be issued via MERX out of sequence.

The following questions have been received from a potential bidder. In accordance with Article 13 under 2003 Standard Instructions - Goods or Services - Competitive Requirements (2011-05-16) which has been incorporated into the RFP in accordance with Article 2.1 of the RFP, the questions and corresponding answers are provided to all potential bidders as set out below:

Question 3:

We are in the process of reviewing the Parks Canada Reservation Service RFP and recognize that there is a significant amount of content to go through. Obviously Parks is providing this level of detail in order to help any potential bidder properly assess the size and scope of Parks' requirements. With this being said, to help ensure there is sufficient time given to the bidding team to build a detailed, compliant and competitive bid, I would like request an extension to the closing date from March 23rd, 2012 to April 12th, 2012.

Based on the timelines described within the RFP, I believe that requesting this extra time would not negatively impact the client's schedule. I hope you agree.

Answer 3:

Yes, the new closing date will be April 12, 2012.
