1.0 Questions and Answers

Q22

In the SOW there are 7 Tasks. The issue we have is that to bid and estimate Tasks 6 and 7...you need to have completed Tasks 1 thru 5. Here is a short extract from SOW Task 6:

- *“3.3.6 Task 6: Development Cycle 3 - Development Cycle 3 will address lessons learned, will provide development time for those requirements that could not be accomplished during the previous development cycles and will offer an opportunity to inject new requirements for enhanced surveillance system capabilities:...”*
- *Task 7 then supports the trials stemming from Task 6.*

The issue is that no Bidder (nor DRDC) will know what those three underlined Task 6 items will actually be until after having completed Tasks 1 thru 5. Therefore, how can we estimate and bid these unknowns and then be evaluated on them?

Q22

The contractor, during the course of the contract will provide delivery of a version of the Surveillance System to DRDC. DRDC will test the delivered system during its planned demonstration periods. The Lesson's Learned to be will be a combination operating procedures, warranty defect arisings and new work. Warranty arising will be covered by the contractor under the contract. Any new work or new requirements could result contract amendments.

Q23

Schedule – what is the expected contract award (CA) date and does the current project schedule as shown in the RFP reflect that CA date or does it now have to change? If it changes, can you please provide an update to the schedule.

Q23

The expected contract award is early April and there are no changes to the schedule.

All other terms and conditions remain the same
