**This amendment is raised to address questions raised during the solicitation period.**

Q92. Please confirm the following is a requirement: three (3) separate ceiling connection poles, one (1) for power, two (2) for communication w/ a minimum interior area of 7752 square mm (12 sqin) for each individual pole.

A92. Yes the above is correct, and is a requirement.

---

Q93. The 55" (+/- 6") panels indicated in the corridors of the floor plan show them having a glazed add-ons. To align with an adjacent 66" (+/- 3") high panel the glazing would need to be as short as 2" and as high as 20" which is well outside of your present allowable range of 12" (+/- 1") to 15" (+/- 1"). Please confirm if these panels are to have glazed add-ons and if there are, should they be expected to align with the 66" (+/- 3") panels

A93. **DELETE:** A 12" screen or 15" screen with a +/- 1" tolerance is acceptable.

**INSERT:** New glazing panel tolerances: We will accept anything between a 229mm to 381mm with a +/- 25.4mm tolerance (9" to 15" with a +/- 1" ).

Q94. Under Accessories (keyboard support surface) you specifically ask for "adjusted by the user through the use of a lever". We are unable to find a keyboard that meets the balance of the specs and uses a lever. Our available option is the use of a knob for tilt adjustment and lever free spring assist "lift and lock" height adjustment. Is this acceptable?

A94. Yes, this is acceptable.
