- 2) answer a Bidder's question raised during the solicitation period:

(a) *The question is as follows:*

I would like clarification with regards to the eventual awarding of the contract, is this an all or none RFP? In other words will the contract be awarded to the company who has the better overall pricing for all of the equipment or will it be award by the best priced components which meet specifications, multiple awarding of this contract?

I would like to request a 2 week extension of the closing date because this RFP was released just before the Christmas Holiday which eliminated at least 2 weeks which could have been utilized to work on this RFP. Also there is an extensive list of equipment which manufacturing time and pricing must be determined in order to submit a complete and comprehensive response, please advise.

The answer is as follows:

Canada will not award multiple contracts under this solicitation. The results of the SRES evaluation process will award a single contract to fulfill Canada's entire requirement.

The 60 day posting period for the SRES solicitation took in to consideration any potential Holiday shutdown while ensuring Canada adheres to its' obligations under various trade agreements. In order to assist bidders, Canada has decided to extend the closing date by an additional one (1) month. The new closing date has been published on the MERX SRES advertisement.
