SECTION A - QUESTIONS AND ANSWERS

Question 1

Am I right in assuming that there will be no evaluations done in the Oct 1- Dec 31 period? For example, if one were to submit a response next week there will be no evaluations undertaken until Jan 5?

Will all evaluation results for any given quarter only be released at the end of the evaluation period, regardless of their submission date? In other words, there is no advantage to submitting well ahead of the deadline date in terms of how quickly the evaluation will be completed and released?

Answer 1

In accordance with Article 2.6 in Component I, Canada reserves the right to conduct the evaluations not less than quarterly. Therefore, at Canada's discretion, Canada may conduct evaluations more frequently than on a quarterly basis. Suppliers may submit their bids at any time. Bids received after the closing date indicated in Article 2.6 will not be evaluated until the next cycle of evaluations.

Canada does not currently intend to issue any Supply Arrangements as a result of the "On-going Opportunity for Qualification" Solicitation until the end of the evaluation cycle indicated in Article 2.6.

Question 2

To confirm the above reference solicitation is not in "addition" to our current SA agreement, but rather an opportunity for us to re-assess whether we would like to qualify for additional Streams? And should we be satisfied with our current Streams we do not need to respond to this solicitation?

Is that correct?

Answer 2

Correct. Suppliers who are currently pre-qualified Learning Services under the Supply Arrangement are not required to make a submission in response to this "On-going Opportunity for Qualification" Solicitation provided that they do not want to submit a bid to become pre-qualified in additional Streams or provide services in additional regions and metropolitan areas.
