This Solicitation amendment number 002 is raised to provide answers to questions on this procurement:

Q2: Is a door required to access trailer interior? Is interior lining required on walls?

A2: As stated in the specifications, the trailers will be modified into mobile clinic component trailers and will have windows and doors cut into the shell by the modifier. No door access is required on the delivered trailers. No interior lining is required for the trailers.

Q3: An angle of .5" x 4" x 4" between the bottom rail and shorter cross members on both sides for added reinforcement to accommodate slide-out modification?

A3: These 3 trailers will be modified into mobile clinic component trailers. They each will have a slide-out requiring additional support to support the overhanging slide-out. To accomplish this, the above angle measurements welded to the sub-frame are required for added reinforcement and support.
