Statement of Work 1.2 Objective

The objectives of the work are to provide DRDC Valcartier, Precision Weapons Section with specialized technical services in the area of whole effect chain concept development and analysis. This includes development of weapons models (small arms, guns, bombs and missiles) and sub-models development (guidance, control, fuzing, fire control, propulsion, airframe), launch platforms, tactical data links, navigation, process modelling, tool development, engagement modelling and simulation analysis (option analysis and trade-off studies). The services will be performed on an "as-and-when-requested" basis. The nature of the services required will advise technology demonstrator projects, applied research projects and technology investment fund projects and technical activities in direct support of the Canadian Forces (CF).
