**Request for Supply Arrangement - Amendment 004****Questions and Answers**

- Q1: Could the Crown please clarify what MPS deliverables may not be acquired through other supply methods like TBIPS?
- A1: All services listed under Annex A "Statement of Work" must not be acquired through other supply methods such as TBIPS.
- Q2: Could the Crown please clarify how departments will be able to ensure best value for MPS services offered, if they are not able to use related service vehicles like TBIPS to compare pricing?
- A2: The Supply Arrangements ensure best value by competing requirements among Supply Arrangement Holders using specific evaluation criteria that will be developed according to the unique needs of each client. The clients will decide how to calculate best value for their requirements, and best value may or may not be the lowest price.
- Q3: In the event that services compliant with your stated MPS deliverables can be offered at a better cost on TBIPS than through a tendering process using the MPS, would departments be able to use TBIPs to procure print related services?
- A3: No. MPS deliverables should not be offered through other supply methods.
- Q4: The time in which this particular RFSA was released has drastically limited the time suppliers have to respond. Since an extension has not been granted yet, would the Crown consider changing the period enquiries can be responded to from fifteen (15) calendar days to five (5) days before the RFSA closing date?
- A4: No. An extension has already been granted on Solicitation Amendment 003.
