Question:

Are there sketches/outlines to assist in the understanding of the trailer?

Answer:

No. That is why we provide guidance at Article 66.1. We want industry to provide us with a draft layout. DND are not the experts in the field of manufacturing trailers.

Question:

Can we submit another method for the fabrication/manufacture of the trailer, which is made entirely of extruded, riveted aluminum, which is much better because all solder on the aluminum removes 50% of its strength.

Answer:

Yes, DND would accept and evaluate an alternative method of fabrication without rendering the bid non-compliant.
