The purpose of this amendment is 1) to response to questions received during the solicitation period and to change the solicitation dated 24-08-2012 as follows:

1) Responds to questions from the industry.

Question 1

What is the construction of the cells' ceiling? Is there a service area above the cells? Or are the ceilings going to need to be chased?

Respond 1

Ceilings are poured concrete, there is no chase above the ceilings, only the mechanical chase at the front of the cell.

Question 2

Is the existing rack supported by a UPS and if so LSMS does not require a dedicated UPS?

Respond 2

Yes but we prefer the bidder to supply a separate UPS in order to ensure the LSMS is kept functionally independent during trial/evaluation of the technology

Question 3

Is 70V the Canadian standard for high voltage audio?

Respond 3

Audio can be delivered to a speaker or annunciator in several modes.
Most common in consumer environments is 8, 4 or even 2 ohm balanced output.
More common in industrial applications where stereo or multi-channel is not necessary are 25v and 70v. Either is acceptable, 70V is more common, especially in PA systems.

Question 4

Is there space at the control post for two 17" TFT monitors?

Respond 4

No space available for two 17" TFT monitor. Unless the second one is mounted on the wall and no interaction required.

Question 5

Am I right in thinking that the support and maintenance of LSMS is entirely the responsibility of the Contractor during the first (12 months - please confirm) warranty period and thereafter the responsibility of a maintenance company appointed by CSC?

Respond 5

You are correct, the support and maintenance is to be done by another contractor.

Question 6

Will remote access, via broadband, to the LSMS control PC be available from the start of the contract?

Respond 6

No outside connection will be allowed. Remote connection will be considered only post the trial but not for the trial system.

Question 7

Here in the UK we undertake monthly "virtual visits" to all LSMS/COMS sites via a remote access package such as PC Anywhere or TeamViewer. During these "visits" it is necessary to have someone at the site opening and shutting doors & hatches. Will it be possible to use CSC staff or will it be necessary to use our local installation partners (in which case the cost will be prohibitive)?

Respond 7

Not for this trial system.

The onus is on the Bidders to arrive at the site visit in a timely manner. Bidders arriving late may not be permitted to attend the site visit.

The Bidder must have at least one attendee at the site visit.

A site clearance obtained for work performed under similar requirements is not acceptable. Bidders should submit in writing to the Contracting Authority, a list of issues that they wish to table and the language they would like to address questions and answers, no later than five (5) calendar days prior to the scheduled site visit.
