Amendment 001 raised to posted the following questions and answers:

Q1: Can you please clarify the room requirements, as there is confusion about the 2300 x 23 room nights and 4600 x 23 room nights.

How many total estimated room nights are required June 10 to July 9, 2013 ?

A1:As we do not know until closer to Tattoo time, late May early June, who we will be tasking we can only estimate numbers. Therefore the lowest we project requiring is 2300 bed nights (100 persons times 23 days) to a maximum of 4600 bed nights (200 persons times 23 days).

Q2. Will there be 2 people in one room with two beds? If so how many estimated are required?

A2:Can be a mixture of double and singles with at least 20% singles for senior personnel

Q3. Lounges? Please elaborate on what is considered a lounge? Would a banquet room with couches and tv's be considered a "Lounge"? Would 3-4 different rooms suffice?

A3:This is required if there are no TV's in rooms. Any rooms with sufficient space to accommodate Canadian Forces Personnel (CF Pers) would suffice.

Q4. Does city sidewalks work for safe running area? As hotel is located in city, or can the safe running area be not onsite?

A4:Yes

Q5. Would the public gardens, wanderer grounds, or National Historic Site, and other public spaces be adequate safe running areas?

A5:Yes

All other terms/conditions remain the same.
