**Question 1:**

How detailed does the RFI response need to be? Does PWGSC want a breakdown of every item in Annex A and B?

**Answer 1:**

Suppliers are to indicate if their company can provide every line item in both Annex A and Annex B. In addition, suppliers are to indicate if any parts are obsolete (and provide the new replacement NSN or part number) or have associated intellectual property.

**Question 2:**

Is it possible to define the material condition more detailed (e.g. new, as good as new, rebuild, surplus)?

**Answer 2:****THE DEFINITIONS OF THE CONDITION OF MATERIAL FOR THIS REQUIREMENT IS AS FOLLOWS:**

**New:** Item has never been used, never refurbished, and has never been a surplus material.

**Like New:** Item was never used, never refurbished, but is currently a surplus material. Item is still within its shelf life.

**Refurbished:** Item was used then went through a repair line. Item was repaired/restored to the latest OEM specs and is now fully operational.

**Used:** Item was previously performing the role/function it is intended to, and is still fully operational.

**Question 3:**

How will the RFP be prioritized (price, delivery time, quality)?

**Answer 3:**

The purpose of the RFI is to determine Canada's strategy, as a result, this procurement is still in the definition phase.
