Failure by the Bidder to provide the required information or in the event that the information cannot be verified shall result in the bid being disqualified and no further consideration will be given to the Bidder.

## 2) Answer questions received from suppliers:

**Q1:** 5.1.1.1 a) says Bidders must submit: "A complete list of names of all individuals who are currently directors of the Bidder;"

**R1:** 5.1.1.1 a) should read as follows: "A complete list of names of all individuals who are currently on the Board of Directors of the Bidder;

**Q2:** Referring to 5.1.1.1 b) which reads "And a properly completed and signed form Consent to a Criminal Record Verification for each individual named in the list." Is a signed original required for each person for each RFP or can we submit a copy of the signed form?

**R2:** It is not necessary for the form to be an original however it is necessary that each individual submit a consent form individually for each separate requirement/solicitation at this time it is hoped that as a database is established this will not be necessary.
