This Amendment 009 is being raised to make the following changes:

A) **INSERT** the following after C.3 Basis of Selection, in Annex C:

C.4 Demonstration Units

1.0 GUIDELINES

1.1 Prior to award of any Contract, a potentially successful Bidder may be required to demonstrate the functionality of the offered production devices in each configuration.

2.0 SET-UP PROCEDURES

2.1 The production devices must be made available for a demonstration of functionality within two (2) working days of notification by PWGSC. Failure to meet this or any rescheduled date may result in elimination without further consideration.

2.2 The devices made available for the demonstration will be used to ensure the offered devices are able to function in accordance with the technical requirements of the RFP and the Departments environment/workflow and therefore must be of the same model as the production devices proposed in response to the RFP and substantially similar in configuration.

2.3 The demonstration units must be made available at the Bidders location in the National Capital Region (NCR), or the Greater Toronto Area (GTA) provided at the time the notification is given to the successful Bidder.

2.4 It is the Bidder's responsibility to install and set up the production device at their site and to demonstrate all of their features and functions.

2.5 If the production devices proposed fail to meet the base technical specifications and operational requirements of the Department, this will result in elimination of the production device without further consideration.

2.6 In the event that the production devices do not function in accordance with the technical requirements of the RFP or are not able to function in the Departments environment/workflow, the Bidder will be required to rectify the failure within 48 hours of notification. The resulting fault will be deemed a technical fault. A maximum of two (2) technical faults will be allowed.

2.7 If the device, or its replacement, exhibits a third technical fault or if the Bidder fails to meet the 48 hour deadline (on the first OR second technical fault) the device will be eliminated from future consideration.

2.8 Notwithstanding compliance to the specifications in Annex A, the production device offered may still be rendered non-compliant at the demonstration if it is not able to function in the Department's environment/workflow. The Department will provide details relating to any fault that eliminates a device from consideration.
