This amendment is being raised to answer questions to date.

Q1) The time between the closing date and delivery of containers to their respective destinations is 4 weeks. This is a very short period of time to award contract, order material, fabricate, paint, and transport. Can the delivery date be changed to 8 weeks after award of contract? If not, please explain why?

A1) The delivery date cannot be changed due to organizational needs.

Q2) Can the specification requirement "6 x lengths of 1" x 1" x 24' steel square tubing 1/8" wall thickness" be changed? A suggested change is from 6 lengths to 3 lengths (6 vertical lengths 58" long per container and supports under sheet metal).

A2) Yes, this suggested specification is an acceptable alternate.

Q3) Can the specification requirement "5 x Lengths of 1" knuckle 2" OW x 72" long .060 guage .187 pin diameter hinge" be changed? A suggested change is from 5 lengths to 1 length of 1" knuckle 2" OW x 72" long .060 guage .187 pin diameter hinge, allowing a quantity 4 -18" long hinges per container. (2 -18" long hinges per door).

A3) Yes, this suggested specification is an acceptable alternate.
