This amendment is raised to answer the following questions:

Q1: I refer you to drawing Project 1021 Sheet No. LV1-02: Marine Division Showcase:

The top of the showcase is called out as millwork to be completed by the Base Building GC. Does this mean that we are not responsible for ANY of the showcase, only for the direct print back panel and the mounting of the artifacts?

A1: All the millwork is being completed by the base building general contractor.

Q2: We are to supply the LED lighting, the implication being that we're installing this lighting into someone else's cabinetry?

A2: The small LED lighting is to be supplied by the artwork contractor, and installed into the millwork.

I refer to the March West Display:

Q3: There are 6 backing panels to this display, one is marked "Millwork", 2 are called out as maple veneer back panels with direct print graphics. Are we to supply ONLY the two printed panels?

A3: In some cases (such as the March West display) the maple veneer back panels are supplied by the general contractor, but made to be removable so that the artwork contractor can provide direct printing. Any displays (murals) that are mounted on mdf are to be supplied by the artwork contractor.

Q4: There is a buffalo head showing in the drawing which is NOT marked as an artifact, are we to supply this? The lances in the drawing are called out as artifacts but the stand is unclear. Are we to build this stand?

A4: All the artifacts - such as the bison head and the lances are existing and will be supplied by the RCMP. This includes the stand for the lances.

All other terms and conditions remain the same.
