**QUESTIONS/ANSWERS**

Q1-1. Your RFP states that approximately 150 reports per year are produced that will require editing. This would be about 3 per week. But without knowing whether these reports are five or fifty pages long, it is impossible to evaluate the quantity of work required. So my question would be: What is the typical word count per report?

A-1. We don't have a "typical word count". The average number of pages per report is 50.
