The Contractor must comply with the insurance requirements specified in Part 6 B, sections 6.1 and 6.2 . The Contractor must maintain the required insurance coverage for the duration of the Contract. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.
