Question 8:

The closing date indicated on the front page of the RFSA states September 30, 2013. Does this mean that the firms have until this date to submit a bid?

Can you please confirm the next closing date for the TSPS RFSA Solutions Based submission?

The MERX posting identifies Q3 closing on January 4, 2013, page 10 of 43 of the RFSA document identifies January 4, 2013, and the front page of the RFSA and amendments refer to September 30, 2013.

Answer 8:

RFSA EN60ZN-090003/C is a permanent posting for TSPS Solution Based Supply Arrangements. However, although it is a permanent posting the solicitation must have a closing date. For administrative purposes, the front page of the RFSA states a closing date of September 30, 2013 for this solicitation. Any adjustments to this date will be made by the TSPS team. The closing date for the permanent posting should not be confused with the closing dates for evaluation purposes stated in PART 2, Article 6 of the RFSA Evaluation Schedule.

As of today (November 30, 2012) we confirm that the next closing date for evaluation purposes is January 4, 2013 at 2:00 PM Eastern Daylight Time (as outlined in PART 2, Article 6, "RFSA Evaluation Schedule").
