QUESTIONS AND ANSWERS

Question12:

I have just received notice of the early closing date on the TSPS Solutions-Based RFSA. It is unclear from the amendment, if suppliers still have until March 28, 2013 to submit their proposals. Please confirm that bidders will still have until March 28 to submit a proposal against this RFSA.

Answer 12:

Canada will be renewing all pillars of TSPS from the Standing Offers, Supply Arrangements for both the Task and Solutions in 2013 to address new Terms and Conditions, incorporate harmonization rules and broaden the scope of services available under TSPS.

In doing so, suppliers who wish to respond to the Solutions RFSA (E60ZN-090003/C) have until March 8, 2013 to submit their bids. After this date, suppliers will need to apply under a new solicitation to be issued March / April.

As per the notice, as a next step, Canada will be issuing a Request for Information pertaining to the renewal and will become accessible as of February 27, 2013 on MERX www.merx.com under reference number E60ZN-13TSSB/A. Suppliers should review this document and provide comments. Following the RFI, once the official solicitation is launched suppliers can seek to pre-qualify for a TSPS Supply Arrangement for Solutions in accordance with the resulting solicitation process.
