The Offeror must propose a minimum of 2 Site Supervisors. Each site supervisor must have a minimum of 3 years experience in supervising moving teams, a valid first-aid training certification, and valid Workplace Hazardous Materials Information System (WHMIS) - Health & Safety certificate.

A moving team is defined as:

One (1) Driver

One (1) Installer

One (1) Mover/Helper

One (1) Supervisor

*The supervisor can also be the driver, installer or mover/helper and is the Offerors responsibility to indicate as such.

The Offeror must submit the resumes and valid first-aid training and Health & Safety certificates for each proposed Supervisor.

The Offeror's proposed Site Supervisors may demonstrate several candidates, however, Canada will only evaluate the first 2 resources identified.
