This Request For Proposal (RFP) amendment 004 is to amend the RFP in order to clarify the Two Step Bid Evaluation Process.

Modifications to the RFP:

10. At document: Volume 1, paragraph 4.1.1:

DELETE	"Proposals that have demonstrated compliance with mandatory requirements at the conclusion of the final review will continue to be evaluated. For scored criteria that require a pass mark, new information provided by bidders that render the criteria compliant following the submission of the new information will be given only the passing mark."
INSERT	"Proposals that have demonstrated compliance with mandatory requirements at the conclusion of the final review will continue to be evaluated. For scored criteria that require a pass mark, if the new information provided by bidders renders the criteria compliant, those criteria will be given only the originally assessed scores."

ALL OTHER TERMS AND CONDITIONS OF THE SOLICITATION REMAIN UNCHANGED
