**Insert:** *CONSEQUENTLY, EFFECTIVE IMMEDIATELY, BIDDERS **SHOULD** SUBMIT WITH THEIR BID, BY THE BID SOLICITATION CLOSING DATE*

2. Delete: article (vi) on section 1.2 Summary

**Insert:** *(vi) Pursuant to section 01 of Standard Instructions 2003, a Consent to a Criminal Record Verification form, **should** be submitted with the bid, by the bid solicitation closing date, for each individual who is currently on the Bidder's Board of Directors.*

3. Delete: Part 4.1.1 Technical and Financial Evaluation - mandatory requirements in its entirety

**Insert:**

- 1) Attendance at the mandatory site visit;
- 2) Submission of Evidence for all items in accordance with RFP Part 3, Section I - Technical Bid; and
- 3) Submission of a Firm Price/Rate in Canadian funds for all the items listed in Part 3, Section II: Financial Bid.

4. Delete: the following paragraphs on PART 5 - CERTIFICATIONS

Bidders must provide the required certifications to be awarded a contract. Canada will declare a bid non-responsive if the required certifications are not completed and submitted as requested.

The Contracting Authority will have the right to ask for additional information to verify the bidders' compliance with the certifications before award of a contract.
