This amendment is raised to answer the following questions:

Q.1: If the Contractor is subcontracting a Hotel, and the hotel has all the liability insurance.. Does the contractor still need to obtain the \$2 million liability insurance?

A.1 Refer to General Conditions 2010C includes in contract by reference.

2010C 06 (2008-05-12) Subcontracts

The Contractor may subcontract the supply of goods or services that are customarily subcontracted by the Contractor. **Subcontracting does not relieve the Contractor from any of its obligations under the Contract or** impose any liability upon Canada to a subcontractor. In any subcontract, the Contractor agrees to bind the subcontractor by the same conditions by which the Contractor is bound under the Contract, unless the Contracting Authority agrees otherwise.

Q.2 Does the insurance need to be Canadian or US ?

A.2 Both are acceptable

Q.3 The Laundry facility, can it be a coin operated service on site?
Or does it have to be included?

A.3 The laundry facility will have to be included.

Q.4 Can the accommodation be a Studio suite (Bed, Sofa, TV, Kitchen, dining table) all in one room or does there have to be a separate bedroom?

A.4 The accommodation has to be a separate bedroom as requested in Annex A of the RFP.

Q.5 Also, is it possible to have 1 x 2br apartment and 1 x 1br apartment to fulfill the request?

A.5 No it would have to be three one bedrooms.

Q.6 Also, can you confirm you would like us to bid furnished one bedrooms?

Q.7 Can you tell me how many people will need to be housed in furnished accommodations? Is it 3 total people? I wanted to confirm as our properties have a maximum per bedroom if they are sharing.

A.6 & 7 Refer to requirement at Annex A of the RFP:

The Contractor will provide CF personnel with the following services:

a. **One of the three options:**

Option A: Three (3) fully furnished, one (1) bedroom apartment;

Option B: One (1) fully furnished, three (3) bedroom apartment, each room having its own washroom for a total of three (3) washrooms

Option C: One (1) fully furnished, three (3) bedroom house, each room having its own washroom for a total of three (3) washrooms

b Location: The property must be located within 20 miles of the Boeing Plant, 5000 East McDowell Road, Mesa, Arizona
