DAOs do not supply rotatable spares, this is an AMO responsibility. Is Canada seeking both an AMO SOA and DAO for the Standing Offer Agreement?

Question: Is there an obligation to respond to every call up? If a company does not participate in a call up do they become ineligible to participate in subsequent call-ups from Canada?

This Request for a Standing Offer (RFSO) is for a National Individual Standing Offer (NISO) ASD requires engineering, prototype design, maintenance support, development of flight-test programs, and certification services from a Design Approval Organization (DAO) for aircraft types owned by Transport Canada and other government departments on an as required basis during the period 1st June 2012 to 31st March 2015.

DAOs may not be authorized to approve ground and flight test plans for avionics and electrical systems certifications depending on complexity. Normally Test Plan approvals are not delegated except in cases where repeating activities are occurring. Please clarify this mandatory requirement.

Clarification is requested in regards to " ... the DAO must have the following certifications", this expression does not correspond with the structure of delegated authority. TCCA standards and guidance materials refer to other terminology, such as "scope of authority", and organizational infrastructures which are considered integral to DAO services. A clarification of intent is requested in this respect.
