I am having problems with data entry for Solicitation Number E60ZN-13TSSB

Within the CPSS, English portion

- ? I selected "Solicitation Dashboard"
- ? I then selected Solicitation Number E60ZN-13TSSB
- ? I then selected "Mandatory Criteria"
- ? I then selected "Click here to edit setup of Group 1"
- ? I then selected Group 1
- ? I then selected "Stream Information"
- ? For each of the 5 stream I selected either "Not Offered" or "Currently Offered"
- ? I then selected "Save"

After having saved my selection, near the top of the page it states: Click "Save" once all selections are completed. The page will refresh and you can click on the "View Categories" link for each Stream in order to indicate the Categories.

Problem: I do not see "View Categories" link for the Streams. Please refer to the photo at the bottom of the e-mail.

Canada's response to question 301:

This solicitation does not contain categories, as per Annex A (page 55). As per Attachment B (page 41) supplier must demonstrate experience for each stream.

The instruction in DCC is modify for the following:

Click "Save" once all selections are completed. The page will refresh and you can click on the "view stream substantiate" to substantiate each stream.

Question 302:

I am in the Mandatory Criteria field and have just filled in which streams we will be qualifying for (Currently offered for Business Consulting, Newly offered for Real Property and Not offered for the remainder). I have clicked save but unlike the instructions, 'view categories' does not appear anywhere. The only thing that appears is under Real Property, and indicates:
View Stream Substantiate for 4. Real Property Project Management Services Stream. When I click on the link, it asks for a Project Number and Cross Reference - I'm not sure what information is being sought.

I entered information in all the fields within the Workforce Reduction Program certification and clicked 'Save'. Why do the 'Amount of lump sum payment' and 'Rate of pay on which the lump sum payment is based' fields appear blank when I return to that page? Has the information in those two fields been saved?

Canada's response to DCC Question 1:

The information input by the bidders in those two data fields is being captured and saved to the database, however it is not being redisplayed on the screen when it is reloaded. A fix for the redisplaying on reload is being looked into.
