The purpose of this amendment is to answer questions from suppliers

Q.1 I want to know if the RFSA is restricted to a service arrangement where the company prepares the media analysis reports as needed by a departments or would it also be acceptable to provide departments with access to a service or tool whereby the representatives from the departments can prepare their own media analysis reports and graphs as needed.

Answer: As indicated in the Annex "A", Statement of Work, it's the supplier that will have to provide the services on an as and when requested basis.

Q.2 Regarding Annex B – Corporate Profile. Is it acceptable to provide a CD-ROM with the bid containing a MSWord file providing the corporate information requested? Also, can suppliers approved following the RFSA see the information posted about their companies on the government's supplier site in order to check for accuracy (given that PWGSC may edit it)?

Answer: The Corporate Profile can be supplied on a CD-ROM with the bid as long as it contains only the required information as indicated in the Annex B of the RFSA. Also, only on rare occasion that the information supplied is altered and if any, the suppliers approval of the alterations will be requested.
