**Question 1-** Can "Diesel Marine Gas Oil ISO 8217 DMA" be added as an alternate product to be used interchangeably for the Zones NS221 93/LT, NS221 93/PI, NS221 93/TW, NS221 93/TW?

**Answer 1-** No alternate products will be accepted for the above zones.

**Question 2-** Is there a requirement to seal the trucks?

**Answer 2-** No. There are no specific conditions pertaining to tank wagon deliveries.

**Question 3-** Is it possible to get dock numbers or exact berthing locations for the following zones:

PQ315 Trois-Rivieres

PQ351 Quebec

PQ501 Sorel

**Question 4-** For Fisheries & Oceans/Coast Guard and DND pipeline supply in Zone NL001 – what is the specific dock location – is there a wharf or section # for the Port of St. John's? For Zone NL001 is there a specific difference in the requirement between F&O/Coast Guard and F&O ?

**Answer 4-** For Fisheries & Oceans/Coast Guard - Wharf/section # would depend on the location of the supplier's pipeline.

F&O/Coast Guard and F&O are requesting the same product, however the requirements have different invoicing addresses.

For the Department of National Defence - Wharf/section # would depend on the location of the supplier's pipeline.

**Question 5-** For Zones BC221, BC251, BC301, BC331, BC441, BC442 and BC511 what is the difference between TW and IV requirements? Are these designations for deliveries into tanks and into vessels respectively or are both deliveries into vessels?

**Answer 5 -** Unless storage capacities are identified, tank wagon (TW) deliveries are into vessel deliveries.

**Question 6-** For IV (Into Vessels) requirements, do the trucks have to go onto the vessel for deliveries or can the deliveries be done ex-wharf?

**Answer 6-** Trucks do not go onto the vessel for deliveries.

**Question 9** - What is the rateability of the volume liftings per location? Is there any seasonality?

**Answer 9-** Annual liftings will not necessarily be lifted equally each month of the year.

**Question 10** - What is the nomination process for delivery of volumes?

**Answer 10-** The Standing Offer terms state a 24 hour notice for delivery, unless specified at Appendix "D" or "E" or as agreed upon by the Contractor and the Identified User Representative.

**Question 11** - Are there specific testing requirements for the Naval Distillate Fuel?

**Question 13** - For ZONE NS221 93/TW, Department of National Defence – it is noted that on occasion, Partial truck loads are required. In these instances is it possible to get an idea of the types of volumes that would be requested if orders are less than a full load which is approximately 37 kl.

**Answer 13** - There is no way of making long range predictions regarding quantities required by truck. Some of the vessels are very small and cannot take 37 kl. Every effort is made to use the Queen's Harbour Master Barge for these small jobs but there are times when it is out of service and truck delivery is the only option.
