## PART 1 - GENERAL INFORMATION

### 1. Security Requirement

There is no security requirement associated with the requirement.

### 2. Requirement

Work to be performed in this goods contract comprise of the furnishings of all labour, materials ,tools and equipment required to fabricate, supply and deliver and install one (1) 100ft at Bedford Institute of Oceanography, Dartmouth, Nova Scotia in accordance with Annex A- Statement of Requirement.

### 3. Debriefings

After contract award, bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days of receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

## PART 2 - BIDDER INSTRUCTIONS

### 3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must

be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

#### 4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Nova Scotia.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

## PART 5 - CERTIFICATIONS

Bidders must provide the required certifications and related documentation to be awarded a contract. Canada will declare a bid non-responsive if the required certifications and related documentation are not completed and submitted as requested.

Compliance with the certifications bidders provide to Canada is subject to verification by Canada during the bid evaluation period (before award of a contract) and after award of a contract. The Contracting Authority will have the right to ask for additional information to verify bidders' compliance with the certifications before award of a contract. ## 13. Insurance Requirements

The Contractor must comply with the insurance requirements specified in Annex C. The Contractor must maintain the required insurance coverage for the duration of the Contract. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.

## **ANNEX "A"**

### **REQUIREMENT**

The Centre for Offshore Oil, Gas and Energy Research (COOGER) in the Department of Fisheries and Oceans requires a large tank for conducting experimental research on oil dispersion in sea water. The contract requirement is for the supply of all drawings, engineering, labour, fabrication and materials necessary to construct and then install the tank on-site at the Bedford Institute of Oceanography (BIO) in Dartmouth, Nova Scotia.

The wave tank must be designed to hold water to the maximum volume capacity of the dimensions of the tank (approximately 38,000 liters). It must be able to support equipment/machinery used to generate and absorb high-energy waves, and withstand the movement of water including high-energy waves and a current flow of approximately 600gpm with no flexing along the walls. It will be installed above ground beside (and to the water side) of the existing tank at BIO.

The tank must be an exact duplicate in all respects of design, construction materials and finishing (i.e. corrosion and weather protection) as the tank currently situated at BIO, with any exceptions/additions as noted below.

The contractor shall provide the following:

- Construct a carbon steel tank with inner dimensions of 100' long x 2' wide x 6' 7" in height.
- Construction shall be of 3/16" thickness carbon steel plates for the floor and walls. Vertical ribbing shall be constructed at 18" intervals along the sides of the tank to support the walls and shall be made of ¼" thick carbon steel. Rib supports are required to provide strength to and prevent flexing of the sides of the tank when filled with water that is either static or in motion.
- The tank will contain a series of ports 6" apart and approximately ½" in diameter that can be fitted with threaded couplings (to be discussed during initial site visit). The ports will run from the bottom to the top of the tank in four vertical rows, one row on each side 9' 10" from the inside front end, and one row on each side 8' from the inside back end.
- The supplier will install two 3" diameter holes in the floor to accommodate drainage pipes. The holes will be situated 6" from each end wall and directly centered in the floor between the side walls. Discussion during the initial site visit will determine the most practical method for attaching drain pipes.
- Stabilizing supports will be constructed and affixed at points along the external sides to provide vertical stability to the tank. The supports shall be positioned in line with concrete footings already located on-site.

- The tank and all associated ribbing and supports shall be sandblasted to provide a clean surface, and then covered with a minimum of three (3) coats of marine-grade paint to protect all surfaces (interior and exterior) from salt water corrosion.
  - Delivery, offloading and positioning of the tank using a crane (provided/arranged by the contractor) on the existing concrete pad at BIO shall be the responsibility of the contractor.

The contractor shall prepare professional drawings of the tank design and dimensions for pre-approval by the client. It is highly recommended that a site visit be conducted to inspect and measure the existing tank to ensure exact duplication as required. This task shall be factored into the contractor's timeline and cost allowance.

### **Deliverables:**

The project will result in the completion of the following deliverables:

1. Site visit with client to inspect and measure existing tank and to discuss any modifications in the design and fabrication required to meet new criteria
2. Submission of professional drawings (AutoCad or other similar method) to client for pre-approval
3. Fabrication, delivery and complete installation (including final positioning, welding, final paint touch-ups etc.) of the tank on-site on a pre-selected (by client) concrete pad located at the Bedford Institute of Oceanography.

### **Modifications and Cancellation:**

The Scientific Authority is responsible for all matters concerning the technical content of the Work under this requirement. Proposed changes to the Statement of Requirement must be discussed with the Scientific Authority and approved by a contract amendment issued by the Contracting Authority prior to acceptance. The contractor is not to perform work in excess of or outside the scope of this contract based on verbal or written requests or instructions from any government personnel other than the aforementioned officer.

### **Introduction:**

COOGER is a national Centre of Expertise (CoE) in the Department of Fisheries and Oceans that conducts environmental research studies related to offshore oil, gas and ocean renewable energy activities. A significant part of COOGER's research is on the science of oil dispersion and development of strategies for monitoring and remediating oil spilled into the marine environment. This includes conducting experiments in a wave tank at the Bedford Institute of Oceanography (BIO) to assess the effects of mechanical and chemical oil dispersion under various energy regimes (i.e. forces generated by different types of waves).

COOGER's research program is expanding, and a second wave tank is required to accommodate the increase in research activity. To this end, a contract is required to construct and install a new wave tank on-site at the Bedford Institute of Oceanography.

The purpose of this contract is to construct and install a new wave tank at the Bedford Institute of Oceanography (BIO). The new tank is to be the same dimensions and design as the existing tank with certain modifications as described in this Statement of Work. The tank is to be delivered and installed on-site by the contractor, and protected with marine paint to prevent corrosion from salt water and ambient weather conditions. The tank is to be built to withstand the weight of its full volume of water and the energy created by a wave generation system in conjunction with a high flow-through system (600 gallons per minute).

## ANNEX "C"

### INSURANCE REQUIREMENTS

#### Commercial General Liability Insurance

The Contractor must obtain Commercial General Liability Insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$2,000,000 per accident or occurrence and in the annual aggregate.

The Commercial General Liability policy must include the following:

**Additional Insured:** Canada is added as an additional insured, but only with respect to liability arising out of the Contractor's performance of the Contract. The interest of Canada should read as follows: Canada, as represented by Public Works and Government Services Canada.

**Bodily Injury and Property Damage** to third parties arising out of the operations of the Contractor.

**Products and Completed Operations:** Coverage for bodily injury or property damage arising out of goods or products manufactured, sold, handled, or distributed by the Contractor and/or arising out of operations that have been completed by the Contractor.

**Personal Injury:** While not limited to, the coverage must include Violation of Privacy, Libel and Slander, False Arrest, Detention or Imprisonment and Defamation of Character.

**Cross Liability/Separation of Insureds:** Without increasing the limit of liability, the policy must protect all insured parties to the full extent of coverage provided. Further, the policy must apply to each Insured in the same manner and to the same extent as if a separate policy had been issued to each.

**Blanket Contractual Liability:** The policy must, on a blanket basis or by specific reference to the Contract, extend to assumed liabilities with respect to contractual provisions.

**Employees and, if applicable, Volunteers** must be included as Additional Insured.

**Employers' Liability** (or confirmation that all employees are covered by Worker's compensation (WSIB) or similar program)

**Broad Form Property Damage including Completed Operations:** Expands the Property Damage coverage to include certain losses that would otherwise be excluded by the standard care, custody or control exclusion found in a standard policy.

**Notice of Cancellation:** The Insurer will endeavour to provide the Contracting Authority thirty (30) days written notice of policy cancellation.

If the policy is written on a claims-made basis, coverage must be in place for a period of at least 12 months after the completion or termination of the Contract.

**Owners' or Contractors' Protective Liability:** Covers the damages that the Contractor becomes legally obligated to pay arising out of the operations of a subcontractor.

**Non-Owned Automobile Liability -** Coverage for suits against the Contractor resulting from the use of hired or non-owned vehicles.

**Litigation Rights:** Pursuant to subsection 5(d) of the Department of Justice Act, S.C. 1993, c. J-2, s.1, if a suit is instituted for or against Canada which the Insurer would, but for this clause, have the right to pursue or defend on behalf of Canada as an Additional Named Insured under the insurance policy, the Insurer must promptly contact the Attorney General of Canada to agree on the legal strategies by sending a letter, by registered mail or by courier, with an acknowledgement of receipt.
