REQUEST FOR STANDING OFFER DOCUMENT

1. Important Notices to Offerors:

DELETE in its entirety **AND REPLACE WITH:**

“Refer to the Part 5 - Certifications, clause 1 (and Annex C and D) for requirements related to the Code of Conduct for Procurement.”

2. Part 5 - Certifications, clause 1 Code of Conduct Cerifications - Consent to a Criminal Record Verification

ADD “The above should be completed and submitted with the offer by the Request for Standing Offer closing date. If the above is not completed and submitted with the offer by the Request for Standing Offer closing date, the Contracting Authority will so inform the Offeror and provide the Offeror with a time frame within which to meet the requirement.
