QUESTION 47:

With regards to sub-requirement # 6 – General, M1 – Rational Technology (Tester), typically clients procure teams of one to three testers on smaller individual contracts. As such, the limit of five contracts to demonstrate the mandatory requirement is prohibitive for many otherwise qualified bidders in the NCR. Would the Crown consider increasing the number of allowable contracts from five to ten for the Rational technology (Tester) sub-requirement?

ANSWER 47:

The request has been considered and is not accepted.

QUESTION 48:

In Amendment 007, the requirement for IDOL technology was removed from sub-requirement 6 as it was unduly restrictive. Similarly, we feel that the required demonstration of billable days against the Rational technology (Tester) unfairly represents a niche testing technology which is not widely used across government departments in the NCR. Would the Crown consider prorating the number of Rational technology (Tester) billable days to less than 1000 billable days and the remaining billable days to be substantiated against similar testing tools/suites i.e. Bugzilla, open source, TestDirector, Visual Studio, etc

ANSWER 48:

The request has been considered and is not accepted.
