**PART A: QUESTIONS AND ANSWERS**

The following questions were received and the official answers are included below.

**Question 12.**

SACC 2035 24 (2012-07-16) Liability - The limit of liability for any damage caused by the Contractor, its employees, subcontractors, or agents to Canada is unlimited unless it is specifically incorporated in full text in the Articles of Agreement. Can the liability be limited to Contract Value and exclude indirect, incidental or consequential damages?

**Answer 12.**

Article 24 of 2035 (2012-07-16), General Conditions - Higher Complexity – Services will not be modified.

**Question 13.**

Annex A, Part II AAHS, Article 4.2.12 - Boarded passenger forecasts: Boarded passengers is historical data and not forecasted data. Based on the standard airline passenger boarding procedures, passengers are only boarded forty-eight (48) hours in advance of flight departure. Given this definition and procedure, can you clarify the requirement for forecasts?

**Answer 13.**

This is no longer a requirement as of the fall 2011, and should have been removed. Please see Amendment to the bid solicitation #7 below.
