SECTION A - QUESTIONS AND ANSWERS

Question 104

For stream 7 project management - part 2 qualification of \$75,000 in end-to-end services for no more than 2 projects raises the following questions:

1. Standard project management effort on a project ranges in the area of 15%. The criteria established in the SOSA assuming a 15% effort means that each of these two projects total costs would be at a minimum \$250,000 each. Is that your intention?
2. Secondly it is common practice to project manage the delivery of eLearning courses from beginning to end. And a 1 hour eLearning course production ranges in the area of \$25,000 to \$50,000. Is the \$75,000 limit associated with a program of courses?
3. Based upon the above does failure to qualify for PM part 2 disqualify a bidder which meets the \$150,000 threshold in M.2(g)(1)?

Answer 104 - Item #1

For M.2(g)(2), Bidders are only required to submit 1 project that meets the criteria. However, Canada will evaluate a 2nd proposed project if the 1st evaluated project does not meet the criteria.

Answer 104 - Item #2

For M.2(g)(2), the dollar value is for the cost of the development of the eLearning Product, including the Project Management Costs.

Answer 104 - Item #3

For Bidders to qualify technically for Stream 7, Bidders must meet M.2(g)(1), M.2(g)(2), and M.2(g)(3).
