DELETE tempered clear glass and **ADD** laminated tempered glass.
- .2 **2.2.4. Components**
DELETE Glass: to CAN/CGSB-12.1. Type 2 - tempered. Class B - float. Thickness: 19.1 mm and;
ADD Glass: to CAN/CGSB-12.1. laminated glass. Laminated tempered glass to meet standards of Ontario Building Code and National Building Code of Canada. Total assembled thickness of laminated panels to be 19.1 mm.
