Here is a list of questions received and the answers to these questions.

Q1. Please clarify Section 3.8 of Annex A. Must all the wheels be pivoting and lock in four positions, including the drive wheels?

A1. Yes

Q2. Please clarify Section 3.9 of Annex A. Must all the wheels be motorized or only as many as needed to perform the required movements?

A2. As many as needed to perform the required movements.

Q3. Please clarify Section 4.2 of Annex A. Is the minimum working length available defined as the distance between the vertical supports, or is it the distance the hoist hook must travel?

A3. The distance between the vertical supports.

Q4. Please clarify section 5.2 of Annex A. Does "move in all directions" mean simply forwards and backwards and make turns?

A4. forwards and backwards, left, right and make turns.

Q5. Please clarify Section 5.3 of Annex A. Does "rotate on itself" mean that the pivot point must be in dead centre of the unit, or simply within the base footprint?

A5. The pivot point must be in dead centre of the unit.

Q6. In section 5.5 of Annex A, may we use a 575V, 3 phase TEFC motor(s)?

A6. Yes

Q7. Please clarify section 5.7 of Annex A. Is a "control box for dangerous areas" defined as explosion proof?

A7. Yes

Q8. Please expand on section 5.10 of Annex A. What is your preference for cable management? Would cables run overhead or would they lay on the floor?

A8. The cables have to run overhead.

Q9. Section 3.2 states 200ft displacement; section 5.10 states 60ft cable reel. Will the system be moved and unplugged as needed?

A9. Yes, we will have several electrical outlet for completing 200ft.

Q10. Please clarify section 5.11 of Annex A. What is the function of the parking button?

A10. To block the crane with the load in certain position for some time if we need to.
