Solicitation EV394-121182/A is amended as follows:

To answer questions from a supplier:

1. Clarify Step 3 on page 29 regarding the awarding of percentages of the contract. As written the lowest offer (#2) is awarded 30%, while bid #1 (2nd lowest) is awarded 50%

Step 3 contains an administrative error. Compliant offers will be awarded as follows: Offer #2 will be awarded 50% of the estimated value, Offer #1 will be awarded 30% of the estimated value and Offer #3 will be awarded 20% of the estimated value.

2. What published pricing will be evaluated? Some companies have old catalogues with very different pricing than their current on line catalogue. This would put bidders at a severe disadvantage if a competitor used the old catalogue and then used their on line pricing or published a new catalogue once the standing offer is awarded.

As stated in Part 4, Article 1.1.1 - the items quoted must be listed in the Offeror's current published online catalogue or printed catalogue. The items quoted must be published in the Offeror's current catalogue, either an online or printed version. The Offeror must provide the documentation identifying where in the current catalogue each item is offered. The published pricing used in the Offeror's current published catalogue will be used for evaluation purposes.

3. If on line pricing is to be evaluated, how do you complete the information per item, as there is no page number on line? Will product number be sufficient?

Product number will be sufficient as long as it is searchable.

4. If a product is listed as a brand item or equivalent and a company carries both the brand name product and the equivalent. Can you bid the equivalent? Can you bid the brand name and the equivalent?

The Offeror may bid either the brand name product or the equivalent. Only one will be evaluated. The Offeror must ensure the equivalent product meets the mandatory requirements identified at Annex A and the technical specifications of the make and model identified in the solicitation. Please refer to SACC Manual Clause B3000T (2006-06-16), Equivalent Products, identified in the solicitation under Part 2, Article 1.1, when offering equivalent products.

5. The Dental instrument basket of goods is very vague. Quality of dental instruments varies widely (as does the price). Can this basket be changed to brand specific only such as Hu-Friedy so an apples to apples comparison can be evaluated fairly?

All the items listed in each basket of goods at Annex B, must adhere to the mandatory requirements listed at Annex A. Brand specific will not be used for dental instruments.

The Offeror must provide technical literature for all the items requested herein under Article 2. Sample Items List B – Dental Instruments. The technical literature provided must identify that each item offered meets the mandatory technical specifications identified at Annex A, Requirement under B. - interchange with an 8mm probe with 90 degree angle.
- interchange with a 13mm straight probe.
