DELETE: Paragraph 7.4 in its entirety.

INSERT:

7.4 SECURITY REQUIREMENT

7.4.1. The Contractor/Offeror must, at all times during the performance of the Contract/Standing Offer, hold a valid Facility Security Clearance at the level of TOP SECRET, with approved Document safeguarding at the level of SECRET, issued by the Canadian Industrial Security Directorate (CISD), Public Works and Government Services Canada (PWGSC).

7.4.2. The Contractor personnel requiring access to CANADIAN PROTECTED information, assets or sensitive work site(s) must EACH hold a valid personnel security screening at the level TOP SECRET, granted or approved by CISD, PWGSC or TOP SECRET SIGINT granted by Communications Security Establishment (CSE), as required.

7.4.3. The Contractor personnel requiring access to CANADIAN CLASSIFIED information, assets or sensitive work site(s) must be citizens of Canada and must EACH hold a valid personnel security screening at the level TOP SECRET, granted or approved by CISD, PWGSC or TOP SECRET SIGINT granted by Communications Security Establishment (CSE), as required.

7.4.4. The Contractor/Offeror personnel requiring access to FOREIGN PROTECTED information, assets or sensitive work site(s) must EACH hold a valid personnel security screening at the level of TOP SECRET, granted or approved by CISD/PWGSC or TOP SECRET SIGINT granted by Communications Security Establishment (CSE), as required.

7.4.5. The Contractor/Offeror personnel requiring access to FOREIGN CLASSIFIED information, assets or sensitive work site(s) must be citizens of Canada and EACH hold a valid personnel security screening at the level of TOP SECRET, granted or approved by CISD/PWGSC or TOP SECRET SIGINT granted by Communications Security Establishment (CSE), as required.

7.4.6. This contract includes access to controlled goods. Prior to access, the contractor must be registered in the Controlled Goods Program of Public Works and Government Services Canada.

In order to gain access to Controlled Goods, the contractor personnel, who DND would deem to be embedded contractors, pursuant to the 2007 Exchange of Letters between DND and the U.S. Department of State, must EACH be citizens of Canada and hold a valid TOP SECRET clearance, granted or approved by CISD/PWGSC.

7.4.7. Processing of PROTECTED/CLASSIFIED information electronically at the Contractor/Offeror's site is NOT permitted under this Contract/Standing Offer.

7.4.8. The Contractor personnel requiring access to COMSEC information/assets must be a Canadian Citizens, hold a valid security clearance commensurate with the information/assets that will be accessed, have a need-to-know and have undergone a COMSEC briefing and signed a COMSEC Briefing certificate. Access by foreign nationals or resident aliens must be approved by the Head IT Security Client Services at CSEC on a case-by-case basis.

7.4.9. The Contractor must complete and submit a FOCI Evaluation Submission Package prior to contract award and it must be determined that a third party individual, firm or government may gain unauthorized access to INFOSEC information.

The contractor should at all times during the performance of the contract possess a FOCI Determination Report issued by Canadian Industrial Security Directorate (CISD) and signed by the Communications Security Establishment in accordance with National Information Technology Security Memorandum 7/90 showing "NO" Foreign Ownership, Control or Influence.

7.4.10. All changes to any of the various FOCI evaluation factors included in the FOCI Evaluation Submission Package must immediately be submitted to CISD for further FOCI evaluation to ensure such changes are examined and an "acceptable ownership, control or influence" determination is passed.

7.4.11. Subcontracts which contain security requirements are NOT to be awarded without the prior written permission of CISD/PWGSC.

7.4.12. The Contractor/Offeror must comply with the provisions of the:

- (a) Security Requirements Check List and security guide (if applicable), attached at Annex D;
- (b) Industrial Security Manual (Latest Edition).
