Solicitation Amendment No. 002

This solicitation is hereby amended to provide the following questions and answers

Q1. Having knowledge of the height of the Workstation panels at HRSDC being 51" high can you tell me if 51" high towers would be acceptable and maybe more appropriate for this location. This would be more in line with the workplace 2.0 Standards.

A1. According to Workplace 2.0, the maximum height of the workstation panels for HRSDC, as well as for all Federal Departments, is 54 inches. However, placing other furniture pieces higher than the workstation panel maximum height of 54" is not prohibited. A 54"- 56" locker/tower will better accommodate our storage requirements for hanging a long coat and placing boots/shoes on the bottom of the locker. This locker height will also result in a side-bookcase which can easily accommodate one adjustable shelf.

Q2. Under Annex A item 9, the request is to have Enamel Paint. Is Powder coated epoxy acceptable which is as durable or better than enamel?

A2. Yes, powder coated epoxy would also be a paint product that we would be willing to accept.
