Q(1) Am I allowed to be the Supervisor and act as 1 of the backup technicians, therefore putting my name in twice on form 6.5.1?

A(1) Yes you may be both Supervisor and back-up technician.

Q(2) How is the performance period to be shown? Is it since we started doing work until end of current contract or is it start of current contract to end of current contract?

A(2) It is to be shown as since you started doing work to the end of the current contract.

Q(3) how do I show how long we have been doing work for each reference? If I have been doing a specific contract for 5 years and it is only renewed 6 months or a year at a time, it will only show that we hold a current contract.

A(3) You should show from the time the contract started to the current date.

Q(4) can I use the same 3 references for everything (company, supervisor and technicians)? Or is it encouraged that I use all different references?

A(4) It is ok to use the same 3 reference, but yes we do encourage that you use different reference if possible.
