QUESTIONS AND ANSWERS

Technical Enquiries:

3.5.1 Vehicle Rating

(a) Gross Vehicle Weight Rating (GVWR) within the inclusive range given as "GROSS VEHICLE WEIGHT RATING" in the Configuration Capability Table; and

(b) Payload within the inclusive range given as "PAYLOAD" in the Configuration Capability table.

Question from Bidder: These have ranges for GVWR and Payload, which is an unusual request and could be difficult to assure we would fall in these ranges for such a custom vehicle. Would it be acceptable to say we would exceed the minimum GVWR and Payload listed on the chart?

Answer from DND: GVWR - Our intention was to ensure that the truck was not too small so as to be insufficient to support toe ambulance body. Accepting that it is above the minimum would be fine.

3.7.7 Shelving, Storage and Mounting Layout

(n) Sink system – A sink and associated system.

Question from Bidder: Do the supply and waste tanks need to be heated to prevent freezing?

Answer from DND: Sink System - As it is intended to use this vehicle year round, a means to keep the tanks from freezing would be required.

3.7.9 Passenger Securement Layout

(a) Casualty Loading System... A manual loading system similar to the current in-service system in the Canadian Forces LSVW Ambulance is preferred.

Question from Bidder: We do not know what this is. Further description or photos are required. Can you provide?

Answer from DND: Casualty Loading System. The stretcher loading system is to be a two-layer system that permits loading stretchers by one individual utilizing a loading system similar to the PROMIL-100 Stretcher Platform as per the attached brochure. The loading system may utilize one stretcher platform with the capability to raise the first stretcher to permit loading the second stretcher, or utilize two stretcher platforms on a fixed height support frame with two levels.

3.7.10 Passenger Securement Construction

(b) i A non-padded water-proof seat with arm rests.

(d) iv Each seating position shall include a non-padded seat made.

Question from Bidder: Please confirm that padded seats are not acceptable.

Answer from DND: Padded Seats - Confirmed, seats are NOT to be padded.

3.14 Paint, Colors and Finishes

(a) The cab hood and roof, and the van body roof shall have a non-skid surface coating applied.

Question from Bidder: Can you provide more information on the non-skid surface coating you are looking for?

Answer from DND: Non-Skid – Any type of anti slip tape is not an option. Suggest to be applying with paint, color of the vehicle, example some thing like the Rhino lining or Linex type of product.
