#### **Section 01 00 10      GENERAL INSTRUCTIONS**

#### **ADDITION OF NEW ARTICLES**

1.0 Add New Specification Items 1.23 & 1.24 to General Instructions Division 01 00 10

##### **1.23 PARKING**

- .1 Contractor's employees can park in the loading dock areas during off-hour periods as stated in 1.3.3 of the General Instructions. During normal working hours contractor's employees are to park in a pay parking lot of their choice.

##### **1.24 LABORATORY EQUIPMENT INSTALLATION**

- .1 Contractor will not be installing any laboratory equipment that is shown on the drawings. Health Canada forces will be responsible for all placement and installation of equipment as shown in Drawing A-1.
- .2 Contractor to protect all new work constructed and coordinate all service requirements of equipment installation with departmental representative.

### 3.0 Reference Mechanical Drawings and Specifications

- 3.1.0 All new supply air ductwork located within the ceiling space of new Lab and corridor shall be thermally insulated. Refer to specifications. All supply air ductwork located within the Mechanical chase "exposed" is not required to be thermally insulated.
- 3.1.1 Mechanical contractor shall allow for the supply and installation of two (2) new fire damper service access doors within existing 500x350 supply and return air ducts located within the penthouse. Access doors shall be located on opposite side of existing, at penthouse slab penetration, within the vicinity of the new exhaust air duct slab penetrations.
- 3.1.2 All ductwork associated with the new exhaust fans (including all accessories) shall be constructed with stainless steel materials. Refer to specification. Ductwork is not required to be welded.
- 3.1.3 New exhaust ductwork located within penthouse shall run at high level. Where ducts penetrate penthouse slab, ducts shall continue up to high level and elbow towards new fans, above existing return air duct main.
