AMENDMENT 001

The purpose of this amendment is to publish answers in response to questions received regarding this TBIPS SA RFP.

THE FOLLOWING CLARIFICATIONS FORM PART OF THIS TBIPS SA RFP:

Question 1) Would Canada be willing to grant an extension to September 5th?

Answer 1) No extensions will be granted.

Question 2) In regards to R-2 for the P.9 Project Manager - ERP PeopleSoft:

“The bidder's proposed resource should demonstrate experience with private sector implementation projects using PeopleSoft HRMS as the enabler which involved business process reengineering to achieve HR best business practices. For project experience to qualify, the resource must have been involved in both the reengineering and implementation phases.”

This requirement asks for experience with private sector implementation projects using PeopleSoft HRMS as the enabler which involved business process reengineering to achieve HR best business practices. Since the Government of Canada version is designed to accommodate the business processes for the management of public service employees, very little re-engineering is required in most departments. There are two exceptions to this rule: The RCMP does not use the Public Service HR processes to manage its member population (police officers) and Department of National Defence does not use these processes to manage its military population. As a result, implementation of HRMS commercial functionality requires analysis and reengineering effort equivalent to that of the private sector.

Would HRSDC consider accepting experience in either of these two departments as meeting this requirement?

Answer 2) No, the requirement shall remain as written.
