AMENDMENT NO. 001

This amendment is hereby issued to address queries and to make clarifications and changes to the Solicitation document including the Statement of Work and Basis of Payment as follows:

Q. Para 1.1 Philosophy in the Statement of Work mentions two day Values Based leadership Training for the successful contractor and that only MG's who have attended the VBL training can deliver training in the contract. Can this training be invoiced outside of the contract or is the contractor expected to incorporate the MG training costs into the overall contract price by exercise? The Same question for the 1 day of annual training Para 2.11.

A. Both training requirements (VBL & Annual training) would be completed after contract award and therefore are to be invoiced within the contract.

Q. Since bidders are required to submit the names of 10 MG's, is 10 the minimum number of MG's that needs to be sent to the training?

A. Yes.

Q. If there are additional spaces available, can contractors send more MG's if they feel more than 10 are required to execute on the training for the duration of the contract?

A. Yes.

Q. Are the upcoming training dates for VBL set and fixed already

A. Yes. They are 29 – 31 May & 03 – 05 Jun 13.

Q. Para 2.22 Equipment states that the contractor must provide Ski Equipment yet there is no line item for ski equipment cost in Appendix B 1a(1)

A. An additional line for equipment hire has been inserted on Annex B. See below.

Q. Exercise Wapta Glide. Should this cost be included in the Guide per Day rate for all of the participants (6 participants Ski Equipment Costs per day)? In other words, should the Ski Equipment costs just be added to the Day Guiding Rate for a total Guide Per Day rate?

A. No - an additional line for equipment hire should be inserted on Annex B. See below.

Q. Annex C Mandatory Evaluation Criteria #6 and #7 reference maximum output per para 3.2.

A. The para should read 2.3 not 3.2

Q. Can you identify what the maximum training throughput is at any ONE period? Is this 10 since that is how many instructors need to be listed as part of the bid? In other words, up to 10 programs can be run at any one time?

A. See Annex B below for details

Q. Para 2.13 Safety references the Contractors Emergency Procedures Plan /RA processes. Should those all be submitted as proof of Annex C Mandatory Evaluation Criteria #29?

A. Yes.

Q. As part of the bid, should proof of WCB coverage required for Annex C Mandatory Evaluation Criteria # 2 (Compliance).

A. Yes.

Q. It is expected that some of the training will be in Alberta provincial parks. Should an Alberta parks permit and Kananaskis Improvement District Business Licence be part of the submitted requirements for Part 1 technical Bid in addition to permits for the mountain parks?

A. Yes.

Q. Beginning at #12 for Annex C Mandatory Evaluation Criteria, the numbering system appears to be different from the other criteria numbering (ie: 4a-f). Can you please update?

BASIS OF PAYMENT FOR EXERCISE MOUNTAINEERING

NOTE: Accommodation costs for British Army participants will be at actual cost without mark-up. Examples include campsite fees or hut fees. Accommodation cost associated with Alpine Mountain Huts or campsite fees are not to be included within these pricings.

YEAR ONE: CONTRACT PERIOD 01 MAY, 2013 TO 30 APRIL 2014

1. Services to be provided during 1 June 2013 - 30 April 2014.

a. Winter activities:

(1) **Exercise WAPTA GLIDE** - A five (5) day expedition of Ski Mountaineering, totalling five (5) courses, consisting of thirty (30) students which requires twenty five (25) MG days, per season, at a firm unit price of:
