Q.1 Many of the hotel properties do not have safes in the rooms.. But have safety deposit boxes located at the front desk. Will this be ok for compliance?

A.1 Safety deposit boxes at the front desk is acceptable

Q.2 If safety deposit boxes are ok, how many are required, as most of the hotel only have between 6-10 at the front desk.

A.2 2 or 3 will be consider sufficient.

Q.3 Is the Hot plate or stove top really required? Or can Microwave and Fridge and coffee maker be sufficient enough?

A.3 A hot plate/stovetop or oven are requested for a suite.

Q.4 SDO (Suite Double Occupancy) does this mean that each room has its own door that opens into the living/kitchen area or would 2 beds in one room with living/kitchen area be ok?

A.4 For a suite, two independent sleeping areas are requested for the personnel engaged in 24 hours activities.

Q.5 Can the hotel offer each CF personnel one single room in replacement of the double rooms? So total CF persons equal 114..We would offer 114 individual rooms. Would this suffice?

Canada would only be charged what is asked for in the "Annex C" but each person would get their own room.

A.5 This is acceptable as the lowest price that will be recommended for award. It was also confirmed that of the requirements for double rooms, it is acceptable that a mixture of doubles and singles be proposed if bidders so chose.
