AMENDMENT 005 TO THE SOLICITATION IS ISSUED TO ADDRESS THE FOLLOWING QUESTIONS RECEIVED FROM A BIDDER:

Q26:

This is follow up to question #12 published in Amendment 002 :

It is requested in the proposal to provide a "Background" count on samples reported as MPN/100mL. Conventionally samples reported with the MPN unit of measure is implicit that the sample was analyzed by either a multi-tube or enzyme substrate method (in a tray) type quantification system. Neither of these systems involve a plate thus there is no opportunity to recover a background count. In this regard, it is then necessary to also run a sample by a membrane filtration method in order to have a plate with a background count to report. Is the intention of the required testing that the initial Total Coliform and E. coli be run by a MPN method along with a membrane filtration method in order to facilitate this request, or is there the option to perform the Total Coliform and E. coli analysis by membrane filtration and report results with a CFU/100mL unit of measure?

A26:

Membrane filtration and reporting CFU/100 ml will be fine.

Q27:

The answer to Q8 (A8(b)) [in Amendment 002], are you able to clarify, are we discussing Xylene (m,p,o). In looking at the CCME CEQG and searching all the water guidelines noted, I am unable to find xylene guidelines. Therefore, is the DL for Xylene (m,p,o) for the water matrix 0.0005mg/L?

A27:

Detection Limit for Xylene (AO (Aesthetic Objectives) only as there is no DL) is identified as <_0.3 mg/L.

Q28:

For the annual DW package in Table 1, are you looking at obtaining testing for all of the microbiological parameters? If so, do you have a list of potential emerging pathogens/protozoa and enteric viruses?

A28:

The DW annual package in Table 1 is for E-Coli, Total Coliforms and HPC only.
