## PART 1 - GENERAL INFORMATION

### 1. Security Requirement

There is no security requirement associated with the requirement.

### 2. Requirement

**2. Submission of Bids**

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

**3. Enquiries - Bid Solicitation**

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

**4. Applicable Laws**

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in British Columbia.

### REQUIREMENT

#### 1. Scope

##### 1.1 Purpose

Base Construction Engineering at CFB Esquimalt has a requirement for an edge bander.

##### 1.2 Terminology

Polyvinyl Chloride (PVC): Plastic

Acrylonitrile butadiene Styrene (ABS): Plastic

Ethylene Vinyl Acetate (EVA): Adhesive

Polyurethane (PUR): Adhesive

#### 2.0 Requirements

A Felder Model G570 with x-motion control or equivalent.

##### 2.1 Technical Requirements

Edge Bander must meet all of the following mandatory specifications:

- Minimum work piece width 70mm, length 140mm
- Panel thickness 8mm - 60mm
- Edge thickness 0.4mm - 3mm for PVC/ABS and up to 8mm in wood strip material
- Must have support table for coiled edge material
- Guillotine shears for cutting up to 3mm thickness in PVC/ABS
- Teflon coated glue pot that has temperature control and on/off switch
- Pressure rollers to feed material and maintain pressure from all sides of work from control panel
- End cutting unit to be adjustable from control panel
- Flush milling unit to be able to adjust: radius, flush, chamfer from control panel
- Corner rounding unit for front and rear rounding, switched from control panel
- Surface glue scraper switched from control panel
- All working units to be enclosed for safety and noise reduction
- Able to use EVA hot melt glue granulate and PUR hot melt glue granulate
- The edge bander must come with a comprehensive operator's manual.
- CSA approved.
- Power must be able to run on a 30A, 208V power supply.
- The footprint of the unit when non-operational must not exceed 4.6 metres in length by 1.2 metres in width by 1.6 metres in height. During operation, the unit may expand outside of these limits.

##### 2.3 Technical Training

The Contractor shall provide technical training to DND employees covering the safe and proper operation of the unit after delivery and acceptance of the unit has occurred. This training shall be coordinated between the Project Authority and the Contractor's Representative, and shall occur within ten (10) working days of the delivery and acceptance of the unit.

The Contracting Authority will have the right to ask for additional information to verify bidders' compliance with the certifications before award of a contract. The bid will be declared non-responsive if any certification made by the Bidder is untrue, whether made knowingly or unknowingly. Failure to comply with the certifications or to comply with the request of the Contracting Authority for additional information will also render the bid non-responsive.

#### 1. Certifications Precedent to Contract Award

Bidders must submit the list of directors before contract award, failure to provide such a list within the required time frame will render the bid non-responsive.

The Contracting Authority may, at any time, request that a Bidder provide properly completed and Signed Consent Forms (Consent to a Criminal Record Verification form - PWGSC-TPSGC 229) for any or all individuals named in the aforementioned list within a specified delay. Failure to provide such Consent Forms within the delay will result in the bid being declared non-responsive

##### 1.2 Federal Contractors Program - Certification

Suppliers who are subject to the Federal Contractors Program (FCP) and have been declared ineligible contractors by Human Resources and Skills Development Canada (HRSDC) are no longer eligible to receive federal government contracts over the threshold for solicitation of bids as set out in the Government Contracts Regulations. Suppliers may be declared ineligible contractors either as a result of a finding of non-compliance by HRSDC, or following their voluntary withdrawal from the FCP for a reason other than the reduction of their workforce to less than 100 employees. Any bids from ineligible contractors, including a bid from a joint venture that has a member who is an ineligible contractor, will be declared non-responsive.

( ) has not been declared an ineligible contractor by HRSDC, and has a valid certificate number as follows: \_\_\_\_\_ .

### 1.3 Former Public Servant Certification

Contracts with former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. In order to comply with Treasury Board policies and directives on contracts with FPS, bidders must provide the information required below.

#### Definitions

For the purposes of this clause, "former public servant" is any former member of a department as defined in the Financial Administration Act, R.S., 1985, c. F-11, a former member of the Canadian Armed Forces or a former member of the Royal Canadian Mounted Police. A former public servant may be:

"pension" means, in the context of the fee abatement formula, a pension or annual allowance paid under the Public Service Superannuation Act (PSSA), R.S., 1985, c.P-36, and any increases paid pursuant to the Supplementary Retirement Benefits Act, R.S., 1985, c.S-24 as it affects the PSSA. It does not include pensions payable pursuant to the Canadian Forces Superannuation Act, R.S., 1985, c.C-17, the Defence Services Pension Continuation Act, 1970, c.D-3, the Royal Canadian Mounted Police Pension Continuation Act, 1970, c.R-10, and the Royal Canadian Mounted Police Superannuation Act, R.S., 1985, c.R-11, the Members of Parliament Retiring Allowances Act, R.S., 1985, c.M-5, and that portion of pension payable to the Canada Pension Plan Act, R.S., 1985, c.C-8.
